Antebellum Manufacturing, LLC ("Antebellum") warrants that Antebellum's aluminum fencing products ("Product") will be free from defects in material and workmanship for the Warranty period beginning on the date of Product purchase. Antebellum further warrants the Product's powder coat finish against cracking, chipping, peeling, flaking, blistering, splintering, corrosion, rusting, abnormal coloration, and fading under normal atmosphere and weather conditions<sup>i</sup>. This Warranty does not extend to products and accessories that are not manufactured by Antebellum, damage caused by negligence, alteration, accident, improper installation, improper storage or handling, abuse, misuse, vandalism, or damage caused by events beyond human control including without limitation damage caused by animals or natural events, impact of foreign objects, fire, earthquake, flood, lightning, hail, hurricane, tornado, other extreme environmental conditions, coastal installations or any other casualty or applications that are subject to heavy salt or mineral exposure or acts of God, movements, distortion, collapse or settling of ground or structure on which the fence is installed.

All claims for a breach of this Warranty shall be submitted to Antebellum within thirty (30) days of discovering the defect in writing specifically describing the nature of the breach, together with a photograph and or samples of the defective portion of the Product and a copy of the original retail bill of sale. Antebellum reserves the right to inspect the defective portion of the Product at Antebellum's factory to determine if the claim is valid. If it is determined by Antebellum, in its sole discretion, that the claim is valid, Antebellum shall at its discretion, either repair or replace the defective portion of the Product with new or equivalent products. This limited Warranty does not cover the costs, including labor, of removal and disposal of the original product, or shipping and reinstallation of replacement product. This limited Warranty does not warrant that any replacement material will match or be identical to the original Product as replacement products may vary in color or gloss in comparison to the original Product as a result of normal weathering.

This Limited Lifetime Warranty covers single family residential properties only and extends to the original purchaser plus one (1) individual transferee if the transfer occurs within thirty (30) years of the original date of Product purchase. Once the transfer occurs, the Warranty shall expire thirty (30) years after the original date of Product purchase. As to any other type of building or property including without limitation those owned by corporations, governmental agencies, partnerships, trusts, religious organizations, schools, condominiums, homeowner associations, cooperative housing arrangements and apartment buildings, the Warranty period will be thirty (30) years following the original date of Product purchase and is non-transferable. To activate this warranty, mail this completed registration card to Antebellum along with a copy of the original retail bill of sale within thirty (30) days of the original date of Product purchase.

The above sets forth Antebellum's complete Warranty and the exclusive remedies against Antebellum with respect to the Product. Antebellum **HEREBY EXPRESSLY DISCLAIMS ANY REPRESENTATION, WARRANTY, PROMISE, GUARANTEE OR OTHER ASSURANCE OF ANY KIND, EXPRESS OR IMPLIED, ORAL OR WRITTEN, STATUTORY OR OTHERWISE, RELATING TO THE PRODUCT. ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS HEREBY EXPRESSLY DISCLAIMED.** Antebellum's liability shall under no circumstances exceed the actual amount paid by purchaser for the defective product, nor shall Antebellum be responsible for consequential, personal injury, special, punitive or incidental damages, whether direct or indirect. No person or entity is authorized to change, modify, or supplement this Warranty, and any such attempt and any other written or implied agreement shall not be valid as against Antebellum.

This Warranty gives the purchaser specific legal rights. The purchaser may also have other rights which vary from state to state. Also, some of the limitations set forth above may not be allowed in certain states and therefore may not apply to particular purchasers.
